GYPSEY LYNN was settled then rallied three wide turning for home, was in a strong drive and was best in the end. YOUR CALL chased the early pace while inside then rallied and moved out to be four wide in upper stretch and was in a strong drive to be second best. TRAVELIN WITCH was unhurried early then rallied three wide on the turn, angled inside to the rail in upper stretch and closed willingly but was no menace to the top two. OLIVIAN set the early pace then bore out on the turn and weakened in late stretch. BOBBY'S GENIE pressed the early pace while two wide into the turn, was carried out on the turn then faltered in late stretch. PRANCIN LADY chased the early pace while three wide, was used up then faltered in the stretch. PRETTYWITTYANDWISE was inside then checked off heels on the turn and trailed.
