ULTRA VIOLENCE set a pressured pace while inside going into the turn, drew off in late stretch and was clearly best. HIT SCENE pressed the pace while two wide into the turn, was in a long drive but was second best in the end. DRUM BUNNY rallied three wide on the turn making a bid strong bid but flattened out in the drive. BARRISTER PROOF was unhurried early then rallied and was four wide in upper stretch, was gaining ground but was no threat in the end. CAUTION CARDINAL was unhurried early then rallied three wide on the turn making a bid but was no menace. FRISCO pressed the pace while inside, was used up then gave ay. ODE TO MY BRO BOB dwelt at the start then was far back on the backstretch and turn while trailing throughout. A steward's inquiry was held concerning the start. After reviewing the film's, no action was taken.
