OUTOFQUEMADO settled not too far off the pace, circled the pack in the upper stretch and showed a late surge to be up in time. BENNY BUCKETS vied for command with FAST CHAZ through the first turn, opted to shadow up the backstretch, shifted out and launched a three wide bid approaching the quarter, flopped leads in the stretch before getting caught late. ENOS SLAUGHTER opted to be the early trailer, began to make progress along the inside after the half mile marker, shifted out three wide to split foes rounding the far turn, entered the stretch just behind the pace and chased on. HERECOMEGEORGIEBOY settled off the pace, steadily advanced up the backstretch, made an inside bid at the quarter pole to enter the stretch in a prominent position, but could not sustain and flattened out. SHOT OF A LIFETIME tracked the pace three to four wide, lacked bid, weakened in the stretch. GOLDEN AFFAIR settled off the pace, trailed after half, passed tired foe. FAST CHAZ showed good early speed, met bids from both sides approaching the quarter pole, gave way soon after and retreated down the stretch. TIMING MALFUNCTION RESULTED IN NO FRACTIONAL TIMES AND A HAND-TIMED FINISH.
