ROWAN AUGUST chased the pace from along the inside, shifted out a path when entering the stretch and launched a bid to take charge at the eighth, kicked away from the field. ROAD RULES rushed up to take charge along the inside before the first turn, met a bid from ROWAN AUGUST at the eighth and grudgingly gave way, held for the place honors. WARREN'S C J tracked the pace between runners through the first turn, settled back a couple lengths up the backstretch, swung out four wide at the top of the stretch and showed a good rally that just missed out on the place award, clear of the rest for show. ROCKSALOT hopped at the start, advanced four wide through the far turn before having to take hold at the three quarters, shifted in towards the inside midway up the backstretch, closed some more ground through the far turn but flattened out in the stretch. PROWLING CAT hopped at the start, moved up to track the pace four wide, was roused at the half and stalked the pace through the far turn but retreated in the stretch. IM GUNNA broke sharply and opted to concede command to ROAD RULES before the first turn, shadowed the pace three wide, began asking at the three eighths but failed to respond, weakened down the stretch. MY FAVORITE FELON was off slowly, trailed after the first turn, made no impact.
