SUPERSONIC BLUE sped to the front, stay in the two path on the backstretch, went well clear on the turn, remained clear and was hand ridden in the stretch. JIMMY B lacked speed, raced in the two path on the turn, swung outside near the eighth pole and rallied nicely. NOW THEN bumped MACNAMARA when bumped and forced in by ABOUT LAST NIGHT leaving the starting gate, chased the winner, drifted out entering the turn and weakened in the drive. ROCKY COLAVITO , steadied in tight quarters mid way down the backstretch, moved to the inner rail on the turn and failed to menace in an even effort. ABOUT LAST NIGHT bore in and bumped NOW THEN leaving the starting gate, chased the pace on the backstretch, was carried out on the turn and weakened. MACNAMARA , bumped leaving the starting gate, stayed along the inner rail on the turn and was outrun. FARENHEIT O C chased the early pace and drifted very wide leaving the turn.
