UPRIGHT veered out sharply at the break, regrouped and moved up wide entering the turn and began pursuit of the dueling leaders, circled five wide with momentum into the stretch, drifted in bothering BRAZEN NOW when advancing inside the furlong grounds, corrected with left handed encouragement, closed determinedly and forged to the front in the final yards. SCOPELLO vied inside a pair of rivals early then emerged in a duel to the inside of FIGHT ME leaving the far turn, poked a head in front while under rating mid turn, kicked away two wide and under a drive leaving the three sixteenths, wandered outward when engaged in mid stretch and ceded grudgingly nearing the wire. BRAZEN NOW , three deep with the early pace, backed off the duelers and stalked, chased four wide and to the inside of the winner soon into the lane, steadied when put in close leaving mid stretch, regrouped and came back on through the final fifty yards. GODDARD , off the dueling leads while saving ground, cut the corner into the lane, remained inside and finished with interest. SON O' SANPETE chased to the inside UPRIGHT leaving the far turn, came two to three wide for the drive, edged up some while between runners past mid stretch then flattened out. SONIC BREES steadied soon after the break, steadied again mid turn, angled out leaving mid stretch but failed to muster up a serious run. FIGHT ME , between runners on a slim lead early, sparred outside SCOPELLO around the turn, chased on three wide past the three sixteenths then weakened. Following a stewards' inquiry and objection by the rider of BRAZEN NOW, UPRIGHT was disqualified from first and placed third for causing interference in the stretch.
