HATAGASAL raced forwardly along the inside, was angled three wide into the stretch, responded to steady pressure and prevailed. CROWN PROSECUTOR settled while three wide, advanced on the turn, was swung five wide for the stretch run and stayed on willingly. CHICKEN WING forced the early pace, took over on the turn and came up empty in the stretch. LOTSA STEEL void of speed, commenced a bid on the turn and produced a belated bid in the stretch. ARIZONA JEREMY chased the pace while four wide, continued four wide into the stretch and lacked a bid. SCOPELLO gained a narrow early lead, was headed on the turn and gave way.
