SONIC SPEED stalked a contested pace while saving ground, took closer order near the far turn, awaited room from the three eighths to the quarter pole, eased out then altered back in past the three sixteenths, bid to command near the sixteenth pole, dug in when confronted by an outer LIMITED HEATWAVE in deep stretch and grittily prevailed. LIMITED HEATWAVE settled in the clear while saving ground, edged up leaving the far turn, angled out and circled five wide with progress into the stretch, ranged up to draw alongside the winner in deep stretch, battled gamely but was kept at bay. DOS VICIOS , a bit reluctant to load, settled off the embattled leaders, advanced three wide into the stretch, shifted out near mid stretch and slowly gained. DEKUDYLAN settled off the pace, swung four wide with some run into the stretch, chased past mid stretch then flattened out. CANE CREEK ROAD disputed the pace outside a rival, gained a slim lead near the half, shook clear soon into the lane, failed to deny the winner's inside bid and weakened through the final seventy yards. LEVON broke slowly, regrouped and made his way forward into the first turn, stalked outside a rival, tipped three wide to make a mild move into the stretch, failed to go on past the three sixteenths and weakened. BUZZINGA KARMA , keen to the lead, handled outer pressure along the inside, dueled from the half mile marker to about the quarter pole then surrendered.
