NEPHELE tracked a contested pace while in the clear, edged up past the five sixteenths then shifted out four wide into the lane, closed in under pressure, forged clear leaving the sixteenth pole under right handed asking then dug in late to deny an inner foe. THEY SEE ME DO IT settled off the pace while saving ground, gained into the lane, altered out leaving mid stretch and closed gamely to the inside of the winner. RUMPUS IN PARADISE steadied when a bit tough to settle between foes in the opening three sixteenths, regrouped through the backstretch run, worked her way between runners while three wide into the stretch, angled out and closed steadily. RAFFINA rated off the leader in the opening furlong then angled out, pulled her way forward to engage that one entering the first turn, pressed to the half, stayed on to chase after the leader cleared, cut back into the margin with a run into the lane, bid between foes to threaten for command in mid stretch, failed to keep pace past the sixteenth marker and faded. MINISTER CONFESSOR sped clear early and secured the inside, was pressure from the three quarter pole to the half, went clear into the far turn then widened past the five sixteenths, was re engaged leaving the three sixteenths and weakened. BELIEVE IN HER was taken to rate early then dropped well off the pace, came three wide for the drive and failed to generate a solid run. RADIANT VIEW broke slowly, recovered and moved up three wide into the first turn, took closer order near the half, failed to keep pace past the five sixteenths, came four wide for the drive, shifted in and weakened.
