CHASENTHEONE tracked the leader early and was two wide on the far turn and inched closer in hand and made a three to four wide bid leaving the turn to draw clear and then remained clear while being ridden out with speed to spare. DOS VICIOS was settled early two wide, then moved to the inside and saved ground on the far turn and made a inside bid leaving the turn but could not gain on the winner late while being second best. BATTLE SCARS was settled on the outside and four wide on the far turn, came six wide into the lane and kept on but needed more late. WAR CHEST was reserved early, advanced four to five wide on the far turn and came seven wide off the bend and had a late rally on the outside. SAQEEL was settled back early and had a belated rally on the inside. PEPPER JACK was reserved early, advanced three to four wide on the far turn but lacked a late rally. MR INSENSITIVE was settled early towards the inside, two to three path on the far turn and lacked a late kick. FAST CHAZ was hard dent to the front and drew clear on the first turn and moved to the inside, then was headed leaving the turn and gave way. LIGHT THE BEAM was settled back early and failed to respond. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
