KENNEBEC stalked the pace behind horses, eased out to the four path leaving the far turn, swept to command in mid stretch and was kept under urging to the wire. SALINE RIVER bumped with BE DECREED leaving the starting gate, stayed along the inner rail on the turns, was in hand behind a rival in upper stretch, found a narrow opening along the rail in mid stretch and closed. BY DECREED , jostled on both sides at the start, showed speed between horses on the first turn and down the backstretch, saved ground the far turn, moved off the rail in mid stretch and weakened. SEVENTEEN BLACK bumped with BY DECREED leaving the starting gate, disputed the pace three wide on both turns and weakened.
