## Footnotes | View Glossary Of Terms

FALL MOON was reserved in the early going, crept closer along the backstretch, roused into the far turn and angled five wide to upper stretch, responded well in the drive, surged in the final sixteenth and got up in time for a determined win. VRONSKY FEINT vied for the early lead then took back into the first turn, tracked the leading pair two to three wide along the backstretch, re-bid into the far turn and vied for the lead between rivals nearing the quarter marker, battled into the stretch then led into the final furlong, was caught in deep stretch and was clear of the rest for second. FOREST ACCLAMATION settled in the second flight and three to four wide early on, was well placed to the backstretch and moved closer approaching the second turn, vied for the lead four wide at the quarter marker, was turned away by VRONSKY FEINT into upper stretch, fought on to the final sixteenth but was outkicked late and was clear of the rest for third. LOVELY LOLA allowed to settle early on, advanced three to four wide at the quarter marker, swung five wide to upper stretch, chased to the furlong grounds and could not muster the needed late response. ROSES R BLUE settled in the second flight, tracked the pace between rivals to the half-mile pole, chased three wide to the quarter marker, ran in pursuit four wide into the lane and lacked the needed late response. HURRICAIN HUNTER was unhurried to the backstretch, saved ground heading into the far turn, advanced along the inside into the stretch, could not sustain her run to the final

sixteenth and flattened out. LOOKOUT PASS settled in the early going, saved ground along the backstretch, swung to three path nearing the top of the stretch, was caught a bit in traffic into the final furlong, found room in the drive but could not muster the needed late response. POKER ALICE was forwardly placed to the first turn, went up and prompted the pacesetter along the backstretch, vied for the lead into the far turn, battled to mid-stretch then weakened in the final stages. OH ANGEL showed speed away from the start and vied for the early lead, took command into the first turn and set a prompted pace into the backstretch, was overtaken into the far turn, chased from the rail into upper stretch and faded in the drive. LITTLE BIT TIPSY settled in the second flight and tracked the early pace, was well placed along the backstretch run, chased two wide into the far turn, lacked the needed response into the stretch and tired in the final stages.
