SONG OF SONGS set the pace inside, drew clear under coaxing around the turn, and kicked on down the lane to hold firm. JOYRIDING stalked in the four path, was coaxed from the three path midway around the turn, angled out to the six path in upper stretch, and ran on to clearly be second best. CHEEKWOOD got bumped by an inner foe at the start, raced up close in the three path, was driven around the turn, floated out to the five path at the top of the lane, and evened out for show. CHICA TIGRE broke out and bumped an outer foe, pressed the winning pacesetter from the two path, lost touch with that foe while being ridden along the inside around the turn, and flattened in the three path down the stretch. CLAM BEACH bumped with an inner foe at the start, raced off the pace in the five path, came under urging from the six path at the top of the lane, and passed tiring inner foes. BOSS GIRL chased inside, was driven into the turn, but faded from the three path down the stretch. TRAIN STATION was wellback along the inside and never a factor. CHIPADA raced in midpack in the two path, was ridden in the three path around the turn, but weakened. EVANS VALLEY GIRL bumped with an outer foe and had to check at the start, trailed in the three path early and never threatened. BY THE LAW raced towards the back of the pack in the five path and never menaced.
