SONIC SPEED saved ground around the first turn, settled in the middle of the pack on the inside for the run up the backstretch, continued around the turn in the two path, began a bid entering the stretch and gained ground to get up for the win late. SHUT UP MICHAEL (IRE) saved ground early, led the way on the inside up the backstretch, continued to save ground around the far turn, kicked clear in upper stretch and was caught at the wire. BROTHER REID raced in the two path around the first turn, settled off the pace on the inside for the run up the backstretch, saved ground around the far turn, began a bid entering the stretch and gained ground late. LAW ABIDING saved ground around the first bend, chased the leader on the inside up the backstretch, navigated the far turn from the two path and was outkicked in the lane. STRADIVARIAN raced in the two path early, tracked the leaders up the backstretch, came around the second turn in the three path and weakened in the stretch. CRAFTY KING raced off the pace in the three path through the opening half mile, swung out to the four path coming around the far turn and never threatened. DOS VICIOS raced in the three path around the first turn, settled in the middle of the pack on the outside for the run up the backstretch, navigated the far turn from the two path and faded in the lane. HONOS MAN raced in the four path early, trailed the field up the backstretch, continued around the second turn in the three path and made no bid. ENOS SLAUGHTER raced in the three path around the first turn, stalked the leader on the outside up the backstretch, came around the far turn in the two path and tired in the stretch.
