RELOAD BABA settled into stride outside a rival into the first turn, stalked about three wide early then advanced outside to the lead past the nine-sixteenths, forced the pace from there, put away the inside rival but was thereupon joined by an outside foe at the top of the stretch, dueled the length of the stretch exchanging several bumps in the process but dug in to get the nod late. CHERVONARUTA tracked the pace from inside in behind, moved out while advancing willingly and in hand three to four wide near the quarter pole, drew even with the leader at the top of the stretch confidently handled and was then asked for run, found a stubborn foe inside, exchanging a few bumps with that one, was ultimately denied. STRAWBERRY WORLD was in a bit tight between runners at the rear early on the first turn, settled to trail near the inside, fanned seven wide leaving the second turn, kept on outside to get up for show honors. BEACH CRICKET settled mid-pack racing off the inside, began to advance mildly three to four wide on the far turn coming into upper stretch five deep, was outfinished for third. HOPE SHE FIRES was quick to take the lead inside, set the early pace then pressed the new leader to the outside, continued inside that one and was urged along past the three-eighths, weakened in the stretch. NILE PASSAGE broke outwardly, raced outside three wide at the back, was never near enough to threaten. SEATTLE RISING was fractious behind the gate unseating the rider, broke well and was urged from the start then continued to race keenly just off the leader two to three wide early, dropped back and faded. TIZARA stumbled then steadied at the start, raced inside at the back into the first turn, made an early advance along the inside early up the backstretch, came up empty. FOLLOWING AN OBJECTION BY

THE RIDER OF CHERVONARUTA AGAINST RELOAD BABA ALLEGING INTERFERENCE NO ACTION WAS TAKEN AND RESULTS TO STAND AS IS.
