MYSTERIOUS BLUES had good speed and proved clearly best. SON OF A SPOON finished well. A SWEET BLAZIN hampered a rival and rallied. BDS SHES A BADGER was edgy in the starting gate and showed late interest. UD LEGYNDARYBOY lacked a rally. TWO SUGAS was bothered early and outrun. EB SHALOM chased evenly. JLM CAYENNES OUTLAW broke outwardly. CD ROCKIN DA MOON was edgy in the starting gate and stumbled at the start. SIXS CB RICOCHET was off slowly and did not factor. FOLLOWING THE RACE, THE TRAINER OF TWO SUGAS FILED AN OBJECTION AGAINST THE RIDER OF A SWEET BLAZIN ALLEGING INTERFERENCE. AFTER REVIEWING VIDEOTAPED REPLAYS, THE STEWARDS DISQUALIFIED A SWEET BLAZIN FOR INTERFERENCE AND PLACED HIM SIXTH.
