REXFORD led the way on the inside up the backstretch, continued around the turn in the two path and edged clear in the stretch. DEAN'S LIST chased the pace setter between horses through the opening quarter, navigated the turn from the three path and could not go with the winner late but kept on to the finish. RED LEADER raced in the middle of the pack on the inside through the early going, saved ground around the turn and finished evenly. ALL THAT GLORY stalked the leader on the outside up the backstretch, came around the turn in the four path and faded in the lane. LITE RANCHIN KID raced off the pace on the inside early, continued around the turn in the two path and made no bid.
