ULTIMATE DECISION led the way up the backstretch, continued around the turn in the two path and just held to the wire. HANK HILL bumped with the horse to his inside at the start, settled off the pace on the outside, continued around the turn in the four path, began a bid entering the stretch and gained ground late. BLACKSOD BAY hit the gate leaving it, recovered to track the leader on the inside up the backstretch, navigated the bend from the three path and chased on to the wire. TEN FIGURES bumped with the horse to his outside leaving the gate, raced off the pace on the inside up the backstretch, saved ground around the turn and showed no kick. DISTORTED CAT stumbled and bumped with the horse to his outside at the start, trailed the field through the opening quarter, came around the turn in the two path and made no bid. AX'S BOUNCY CAT stalked the leader on the outside through the early going, saved ground around the turn and faded in the stretch.
