## Footnotes | View Glossary Of Terms

IVORY MOON led the way on the outside up the backstretch, navigated the turn from the two path and kicked clear in the lane. BELLA BABY pressed the pace on the inside early, continued around the bend in the three path and chased on to the wire. JULIA'S PROMISE stumbled leaving the gate, raced at the back of the pack on the outside through the opening quarter, came around the turn in the two path, began a bid entering the stretch and gained ground late. SUPER ENTICING raced at the back of the pack on the inside through the opening stages, swung out to the five path coming around the bend, began a bid passing the quarter pole and improved position from there. SNOW FLURRY raced off the pace up the backstretch, navigated the turn from the four path and showed no kick. ANNA B chased the leader on the outside up the backstretch, continued around the turn in the three path and weakened in the lane. BIRDIE CURDY raced in the middle of the pack through the early going, came around the bend in the three path and was empty from there. LOOKATHERGLIDE tracked the leader on the inside up the backstretch, saved ground around the turn and tired in the stretch.
