BRILLIANT JOURNEY, sent to the early lead, set the pace while staying near the inner rail and was under urging in the drive. RAVEN MOON bumped with CLEVELAND POWER leaving the starting gate, was in hand behind horses entering the backstretch, hugged the inner rail the far turn, eased out in upper stretch and finished evenly. RED HEAD KID, along the inner rail the first turn, moved to the two path on the backstretch, chased the winner and faded. CLEVELAND POWER bumped with RAVEN MOON at the start, was three wide both turns and weakened. CHECK THE FACTS, four deep the first turn, was outrun. CARSON N SPENCE stayed along the inner the far turn and weakened.
