SHIP IT RED stalked the pace, rallied four wide into the stretch, bid willingly to duel and drew off near the sixteenth pole. PARETO'S PRINCIPLE set the pace, responded to duel, yielded near the sixteenth pole and held for place. TEST PILOT stalked the pace along the inside, bid along the rail on the turn to contend, hung late and was outfinished for second. FAMILY TRADITION was void of early speed, put in a steady effort to improve his position and was not a threat. JOHNNY UP raced mid pack, lacked a stretch response and dropped back. MONGOLIAN MOON was taken outside early, trailed the field, was not urged and showed little. The rider of PARETO'S PRINCIPLE claimed foul against the rider of SHIP IT RED for alleged interference in late stretch. No change was made.
