Footnotes | View Glossary Of Terms

SWEET TREASURE stalked three wide, bid in the four path entering the lane, forged an advantage while tucking down to the three path in upper stretch then drove clear at the furlong grounds. STORM MIAMI (IRE) stuttered a step at the start, stalked along the inside, awaited racing room while encountering traffic in the two path turning for home, split foes to take aim between rivals as an outer SWEET TREASURE forged an advantage in upper stretch, failed to sustain a bid inside of that one coming to the furlong grounds, then chased that one home and held show from an outer challenger late. GOLDEN SUNSHINE laid off of the pace in the four path, tucked to the inside while trailing into the backstretch, moved out while progressing turning for home, but steadied when blocked between rivals in the five path in upper stretch, tipped out upon recovery and rallied to be denied place late. CHEETAH LADY trailed along the inside, improved into the backstretch, took the far turn in the two to three path, bumped rivals while forging between foes four wide in upper stretch and stayed on. LUCKY SPEECH pursued from midpack in the two path, then between horses down the backstretch, took the far turn in the four path, took aim from the six path entering the lane, but only managed to chase before yielding between horses in the final furlong. PRETTY SASSY raced off of the pace in the three to five path, gave way around the far turn before getting floated to the seven path into upper stretch and failed to factor. PRETTY LAYLA set the pace along the inside, vied with an outer prompter around the far turn, got headed by an outer bidder in upper stretch and weakened. YAMILE'S

raced forwardly two wide, pressed into the backstretch, vied rounding the far turn, but weakened three wide and between foes in upper stretch.
