## Footnotes | View Glossary Of Terms

SPIKEZONE hopped at the start, chased in the three path, was driven around the turn, angled out to the seven path at the top of the lane, rallied past inner foes going by the furlong grounds and edged clear. SHOWSTOPPER COPPER bobbled at the start, tracked in the two path, waited behind rivals around the turn, angled out to the six path in upper stretch, and ran on to split place honros. RADICAL RIGHT stalked in the three path, floated out to the five path entering the lane, and kept on to hold a split of place. S S SINATRA trailed inside but improved along the rail down the stretch. NORTHERN FLAME set the pace inside, was driven from the rail around the turn, tipped out to the two path at the top of the lane, but yielded passing the eighth pole. AUGUSTA MELODY pressed in the two path, vied between foes around the turn, tipped out to the three path entering the stretch, but weakened in the final furlong. ARDEN'SLUCKYTOBE prompted the pace in the three path but gave way in the stretch.
