FAVORITE ROAD veered inward impeded inside foes at the start, quickly recovered took control of the tempo around the first turn, sprinted away down the backside, left lead well clear, held sway driving through the wire. TOBI WAN KENOBI very slow into stride, under urging way off the pace into the far turn, split foes turning for home, rallied inside through the final sixteenth up for the place. COURT TUDOR clean start, chased the speedy front runner two deep through out, under pressure inside the sixteenth marker, evened out to the wire. JUBAGOTTHEMONEY bumped, pinched back at the start, outrun into the far turn, advanced in tandem outside TOBI WAN KENOBI leaving the quarter pole, flattened out through the final stages after a rough start. BULL RIDER tracked the pace four wide down the back stretch, under urging drifted wide around the second bend, gave way through the lane. SISTER WINNIE bumped at the start, saved ground throughout, roused on leaving the furlong marker, weakened to wire. THERE WAS A JOCKEY'S OBJECTION IN THIS RACE, THE RIDER OF JUBAGOTTHEMONEY CLAIMED FOUL AGAINST THE RIDER OF FAVORITE ROAD FOR INTEREFERENCE AT THE START, AFTER THE JUDGE'S REVIEW THE RESULT STOOD OFFICIAL NO CHANGE.
