SHEWONTTALKTOME hustled up soon after the start, set a pressured pace along the rail into the far turn, stifled outside bidder leaving the guarter pole, clear turning for home, held safe driving through the final sixteenth. SOMESUGARNSPICE outrun out of the picture into the far turn, angled five wide for clear run at the leader leaving the sixteenth pole, rallied late nailed down the place at the wire. WYNSOME CAT raced towards the rear into the far turn, rail bid leaving the quarter pole, all out inside while never able change leads, stayed on well nipped for the place at the line. SERENADE ME chased the pace two wide into the far turn, under pressure flattened out through the final stages. LONA LEE bumped back at the start, inside pursuit leaving the quarter pole, came up empty late. LOVING GAZE (IRE) bumped pinched back at the start, tracked the pace three wide into the far turn, eased home.
