## Footnotes | View Glossary Of Terms

BAKK N BEAUTIFUL led the way into the backstretch, responded to a challenge from POUR HOUSE at the head of the lane, and held under a drive. POUR HOUSE sat in striking range, went in pursuit of the leader in the far turn, angled out at the head of the stretch and missed after a game effort. ARTIC CAUSEWAY saved and lacked a kick. NINEOCLOCKSOMEWHER mild late interest. ATTHEBARGETNTIPSY was in traffic leaving the opening turn, and had no response. SKYLAND DANCER raced greenly and took back in the backstretch. RIVER ROCK FIRE fractious in the gate, fanned four wide into the opening turn, and was outrun. JOCKEY OBJECTION- An objection was lodged by the rider of POUR HOUSE against the rider of BAKK N BEAUTIFUL, alleging interference at the head of the stretch. After review of the Stewards, the objection was disallowed.
