STONEVICIOUS was outsprinted to the opening turn, contested the early pace outside of QUINTO SOL, dueled in the far turn, drew clear entering the stretch and was ridden out. TAYLOR FIELD trailed the field early, moved up into contention leaving the backstretch, drove three wide in the final turn, and edged clear late stretch to secure a second-place finish. KYSTONE sat midpack while three wide, and was outkicked. IT'S A FACT vied three wide into the opening turn, stalked the dueling pacesetters, rallied into the stretch and yielded. PARKING PERMIT passed tiring rival. QUINTO SOL emerged the leader entering the backstretch, dueled inside of STONEVICIOUS, was unable to move on with the eventual winner and gave way.
