HEY BIG UN was the first out of the gate to set the pace through the first turn, settled back behind the pace up the backstretch, split foes in the far turn to reclaim the lead going into the stretch and kicked clear. PREACHA MEYERS raced not too far behind the pace, made a three wide bid in the far turn to challenge the lead, had no closing bid in the stretch. TOP BLOOD pressed the pace through the first turn before claiming the lead at the top of the backstretch, contested by foes in the far turn before steadying at the five sixteenths pole. POSSUM settled back to trail throughout, no factor. JOCKEYS OBJECTION BY TOP BLOOD ON PREACHA MEYERS FOR INTERFERENCE IN THE FAR TURN WAS DISALLOWED AND NO CHANGE WAS MADE.
