THIRTY WEST saved ground setting the pace, drifted out slightly during the drive and maintained a safe advantage. ALRASIKH was reserved off the pace while racing three-wide, responded when asked and closed strongly. SILK SUIT saved ground chasing THIRTY WEST, slipped through during the drive and finished in a mild rally. PUJOL was reserved off the pace, moved up three-wide nearing the quarter pole and rallied late. BASIC MILES settled in the middle of the field, moved up four-wide nearing the quarter pole, offered a mild bid entering the stretch and then went evenly late. BLUE SKY'S SYL hopped at the start then raced in the back of the field, came three-wide into the stretch and improved his position. JO BEE BRAT was unhurried, rallied five-wide into the stretch but failed to seriously threaten. CHOCOLATE BROWNIE dropped back early, came three-wide into the stretch and was not a factor. AMERICAN LITIGATOR raced in the middle of the field early while two-wide and tired. CHOPPA was forwardly placed early racing along the inside and gave way.
