CORPORAL VIOLETTE (IRE) tracked along the rail, crept closer on the backstretch, drafted behind the leader on the far turn, angled out in the lane and got up in time. STARTS NOW was closest in pursuit near the inside early, drew closer leaving the backstretch, bid two wide on the far turn, took over past the eighth pole but got outkicked by the winner in the end. DELIGHTFUL LAURA established the front quickly and crossed over, took pressure around the far turn, dueled into the final furlong and yielded grudgingly to the top pair. SHE'S A JOKER settled in the two path, followed in range on the far turn, finished willingly down the lane and earned a minor award. QUEEN SIENNA (ARG) tucked inside at the back, gained three wide on the far turn, angled out widest in the drive and produced a mild rally. ANGELIC APPEAL (IRE) broke a step slow, reserved along the inside in the opening stages, had one rival beat leaving the far turn, steered out in upper stretch and gained ground late. MOTET sat off the pace in the two path, remained two wide around th far turn and lacked a response when called upon. ESMERAY (IRE) pulled a bit when reserved along the inside early, chased within striking distance on the far turn, sustained an injury in upper stretch and pulled up, then was transported off the track via equine ambulance. THE STEWARDS REVIEWED THE STRETCH RUN CONCERNING ESMERAY (IRE) AND RULED NO ACTION WOULD BE TAKEN.
