## Footnotes | View Glossary Of Terms

CLUBHOUSE CUTIE pressed three deep to the turn, dueled from outside around the bend, kicked clear in upper stretch and was ridden out to the wire. ANTE UP TONY tracked out of range on the inside to the turn, gained while angling to the three path around the bend, finished determinedly in the lane but had to settle for second best. TURKEY BIRD tossed her head leaving the gate to spot the field a few lengths, advanced from the inside to two wide on the turn and showed late effort to gain third. AMELIA'S ECHO dropped back when climbing along in the early going, exited the backstretch in the five path, moved into the four path around the bend and rounded out the superfecta. MY KIMMIE tracked four wide into the turn, lost ground while moving to the three path and weakened in the lane. SURFIN CANDY set the pace inside a pair of rivals up the backstretch, dueled around the turn, yielded to the winner in upper stretch and weakened in the final furlong. BY THE MOONLIGHT hit the gate and came away very slow, trailed well off the rail in the early going, angled down to the two path around the bend and could not make an impact. WEST FRESNO pressed between rivals, was getting out and dropped back around around the bend, then tired down the lane.
