PINFIRE stalked close up in the two to three path, bid along with an outer rival to vie between horses at the quarter pole, battled with his inner game counterpart through the late stages and narrowly prevailed. BIG EFFECT vied three to two wide, led in the two path into the turn, met a pair of outer challenges turning for home, dug in and dueled gamely with the eventual winner through the final furlong but missed. GUNNER BAY advanced outside of rivals to track four wide into the turn, bid three deep while still in the four path nearing the quarter pole, vied into the lane, but failed to keep pace with an inner pair while hanging on his left lead leaving the furlong grounds, changed over and held show. CAT ON TIME laid well back in the two to three path, swung out to the six path into upper stretch and rallied willingly. DEER DISTRICT raced off of the pace three wide, took the turn in the four path, floated to the five path into upper stretch and ran on evenly. GATESKEEPER vied along the inside, failed to sustain level terms and chased his outer counterpart into the turn, moved to the three path turning for home and gave way while hanging on his left lead. MARKET STREET raced off of the pace two wide and

between horses and failed to factor. ZAMBEZI saved ground in midpack and gave way. GUNFLASH broke a step slow, trailed in the four path, fanned out to the seven path into the lane and made little impact. LOUISIANA JESS broke outwardly, tracked three wide and between horses, chased among foes around the turn and weakened.
