LITIGATION stalked in the three path, ranged up in the four path along with an outer rival turning for home to offer a bid between horses at the quarter pole, moved past the leaders along with his outer counterpart entering upper stretch, gamely battled with that one through the final furlong and narrowly prevailed. TROUBLESHOOTING stalked in the four to five path, advanced to bid along with an inner counterpart turning for home, vied into upper stretch, dueled gamely with that inner aforementioned foe through the final furlong but missed at the wire. HIT THAT REVIEW (IRE) laid off of the pace near in the inside, closed in on main group two wide nearing the lane, fanned out to the five path in upper stretch and ran on to gain show at the sixteenth pole. SHAN trailed in the two path, spun to the four path into upper stretch, shifted out whlie staying on and moved up willingly. STAR'S IMAGE leaned inwardly and bumped a rival at the start, sparred for the lead two wide and between horses into the turn, got headed by his outer counterpart at the three furlong pole, fought on while inside of a trio of rivals into the lane but weakened through the final furlong. TAYLOR'S VERSION dueled three wide, forged an advantage passing the three furlong pole, but got headed between horses entering the lane and faltered. HOFF was bumped by an outer rival leaving the gate, dueled for the lead with an outer pair into the turn, yielded in hand leaving the three furlong pole, checked slightly at the five sixteenths marker and caved.
