FOR FILLIES THREE-YEAR-OLDS . Free nomination, \$500 to pass the entry box and \$500 additional to start. Supplementary nominations may be made at time of entry by payment of \$1,500 (includes entry and starting fees). \$100,000 Guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth Weight: 122lbs. Non Winners of a graded sweepstakes in 2025 allowed 2, lbs. a sweepstakes since March 12, 4 lbs. Starters to be named through the entry box by the usual time of closing. The maximum number of starters for the AUDUBON OAKS will be limited to fourteen (14) starters. Preference to start will be given to graded stakes winners (in order I-II-III) then those horses having accumulated the highest lifetime earnings. A trophy will be presented to the winning owner. Nominations closed on July 26th, 2025 with 22 nominations.

STURGEON MOON tracked along the inside, shifted out four wide at the quarter pole, rallied to reel in the leader at the sixteenth pole and drew clear. PRINCESS PROUD pressed two wide and between horses, bid to vie between rivals into the far turn, led at the quarter pole, kicked clear in upper stretch, but was caught by an outer bidder at the sixteenth pole, tired yet lasted for place. TRUSTY TROUTMAN broke a step slow before clipping a rival's hind heels soon after the start, trailed in the aftermath, launched progress in the three path turning for home, rallied between horses into the final sixteenth and missed reaching place. VIRAL PLANE LADY had her hind heel clipped after crossing over an inner rival's path at the start, set the pace along the inside, vied with a pair of outer bidders into the turn, got headed nearing the five sixteenths pole, steadied back at the quarter pole, yet recovered to keep on in upper stretch, rebid for show in the final furlong but got outkicked. HOLLYGROVE stalked four to three wide, bid into the far turn, vied turning for home, but gave way in upper stretch and faded between horses. RUN CAMILA RUN chased three wide, floated five wide at the quarter pole and tired. RUBY'S GHOST raced off of the pace in the two path and got outrun. THE RIDER OF VIRAL PLACE LADY CLAIMED FOUL AGAINST PRINCESS PROUD ALLEGING INTERFERENCE AT THE QUARTER POLE, BUT THE OBJECTION WAS DISALLOWED BY THE STEWARDS.
