AFTER MY OWN HEART was reserved off the pace racing three-wide, came five-wide into the stretch and finished fast to be up in the final strides. HAUGHTY KITTY chased PROFF OF JAZZ racing two-wide, moved up to challenge that one nearing the quarter pole, gained the lead at the eighth pole and then held on gamely to just miss. PROOF OF JAZZ saved ground setting the pace, responded when challenged and held on determinedly for third. LUCY L was prominently placed racing four-wide but lacked the needed late response. PRINCESS K was allowed to settle, moved up two-wide nearing the three-eighths pole, continued to be two-wide into the stretch while gaining ground back lacked room in the final sixteenth. ENGLISH DANGER raced in the back of the field early, came four-wide into the stretch and failed to threaten. LUVAHAPPYENDING was unhurried early, came two-wide into the stretch and was not a factor. POKER ALICE was forwardly place early racing two-wide and weakened. STAY N LOV broke in then moved forward along the inside to be prominently placed for to the three-eighths pole and tired.
