## Footnotes | View Glossary Of Terms

CAJUN CATTITUDE sent hard for the lead, set solid pace, dug in when challenged by SECRET ROCKET at the top of the stretch, gamely kept a head in front until the finish and had to share the top prize. SECRET ROCKET tracked inside behind the pace, went to challenge CAJUN CATTITUDE for the lead approaching the quarter pole, dueled gamely through the stretch, edged closer as the wire approached, and was even up on the line. LADY CHERYL'S SONG was the outside horse in the third pair down the backstretch, rallied four-wide through the turn and finished up well, closing the margin, but could not get to the top two. GIRL FROM DE BAYOU raced inside of a rival as the main pack split into three pairs, kept on late and was mildly gaining, but came up short of a minor award. IMPERIAL ASSAULT hustled from the break, pressed CAJUN CATTITUDE down the backstretch and into the turn, weakened late

on the turn and was outfinished in the stretch. TRANQUILLA void of any speed, went very wide on the last turn, taking BREWSTER COUNTY out as well, was never a threat. TWENTY FOUR GRAND chased three-wide behind the early pace, then struggled to keep up midway on the turn and tired in the stretch. BREWSTER COUNTY dwelt at the start, spotted the field a double-digit head start, caught up with a rival on the turn, then got carried eight-wide and was never a factor. STEWARDS INQUIRY INTO THE START FOR BREWSTER COUNTY, AFTER A REVIEW IT WAS DETERMINED THAT SHE DWELT TO CAUSE HER OWN PROBLEMS AND DECLARED A STARTER.
