LAST PENALTY was sent to the front, set a pressured pace along the inside, drew away for a clear lead entering the stretch, was under pressure late and just lasted. IMAGE OF ME was rated early, bid along the rail on the second turn, shifted out for the drive, closed steadily, was gaining late and was transported off the track via an equine ambulance. ALLTAIL pressed the pace two across to the second turn, dropped back, went evenly late and held safely for show. EMBRASSER raced close to the pace, showed speed to the second turn, flattened out and faded through the stretch. MISS DAAHEN trailed around the first turn, moved up outside along the backstretch, loomed a threat on the turn and stopped. CACTUS CAT raced close to the pace along the inside, was through early and outrun.
