EVE OF EVE prompted two wide, vied down the backstretch, drove clear entering the lane and held sway from a single pursuer. FRET NO MORE tracked while tucking from the three path to the inside around the first turn, saved ground before inching closer while tipping to the three path at the quarter pole, claimed place before taking aim on the clear leader entering the final furlong, but was kept at bay thereafter and proved second best. INSTASPEED was briefly antsy in the starting gate, stalked outside of the top pair, applied mild pressure before chasing them from the four path around the far turn, yielded between rivals at the quarter pole, yet kept on to reclaim show in upper stretch and held that position. A MISS DEAMEANOR tracked two wide, ranged up outside of the top pair and from the four path around the far turn, bid and gained an advantage entering the lane, drove clear then held sway. STEAL ME OVER raced off of the pace along the inside, gained ground in the two to four path in to the lane and ran on to be second best. JAYDYN CAT pressed outside off the leader early on, checked and altered course inwardly to gain an advantage from that troubled foe nearing the backstretch, led in the two path from an outer presser into the far turn, disposed of that one before meeting the eventual winner's challenge nearing the lane, got headed entering it, gave way and narrowly saved show. LIGHTENING MO broke a beat slow, lacked speed two wide before tucking to the inside into the backstretch, saved ground around the far turn, then staved on to miss show. BETSY'S ALL IN raced at the rear in the two to three path, advanced into and around the far turn, fanned out to the five path into the lane and flattened out. GUITAR BOY bumped with an inner foe leaving the gate, stalked in teh three path, bid outside of the leader and from the three path around teh far turn, vied while wrestling an advantage entering upper stretch, clung between rivals at the three sixteenths pole as an outer BOLTANO bid, but got outkicked by that one in midstretch and was second best. PRETTY CAPABLE saw her stall doors opened when an inner rival broke through his pre-race, tracked along the inside, took aim in the three path and between the leaders in upper stretch, brushed an inner rival while inching between those foes at the three sixteenths pole, dueled before changing leads nearing the final sixteenth, shifted out and edged ahead late. 
