CALICOCO set the pace racing off the rail, responded to pressure while drifting out slightly during the drive and was fully extended to prevail. PASSING JUDGMENT was forwardly placed early while racing three-wide, angled to the inside for the drive and finished fast to just miss. HOUSE BOURBON was prominently placed early while racing two-wide, came three-wide into the stretch and finished well for third. FRAN'S STAR raced in the middle of the field early, came four-wide into the stretch, angled in during the drive and rallied late. MI SOLUTION saved ground early while being allowed to settle, came three-wide into the stretch but lacked a rally. ICE'M UP BOYS was reserved off the early pace, came four-wide into the stretch and failed to seriously threaten. SONYA KNOWS BETTER broke in to bump with AMERICAN DOLLARS the settled in the middle of the field, came three-wide into the stretch and failed to be a factor. COFFEE COUNTY broke out at the start bumping with AMERICAN DOLLARS then raced close-up for six furlongs, came four-wide into the stretch and weakened. NORTHERNREFLECTION was unhurried early, came three-wide into the stretch and failed to menace. AMERICAN

DOLLARS was bumped from both sides at the start then dropped back and failed to be a factor. CATCHIN DRAMA raced in the middle of the field early and tired.

BEAUDEAN set the pace racing slightly removed from the rail, drifted out late to bump with REGATTA BAY and was fully extended to hold that one off. REGATTA BAY was prominently placed while racing three-wide entering, moved up to offer a bid to BEAUDEAN nearing the quarter pole then was bumped and carried late by that one and just missed, but following a stewards inquiry and jockey's objection was declared the winner via disqualification. M L BRODY'S GEM was close-up throughout racing along the inside and finished in a mild rally. REXINATOR was allowed to settle, came three-wide into the stretch but lacked a rally. IRON FORTUNE settled in the middle of the field, came five-wide into the stretch and went evenly late. COMPUTERIZED steadied from between horses while in tight early, then moved up three-wide nearing the three-eighths pole to be forwardly placed and weakened in the late stages. VALID EARLY dropped back early and was not a factor. V CUT prompted BEAUDEAN early while racing two-wide and tired. FOLLOWING A STEWARDS INQUIRY AND JOCKEY OBJECTION BY THE RIDER OF REGATTA BAY, BEAUDEAN WAS DISQUALIFIED FROM FIRST AND PLACED SECOND

WISE VERDICT was prominently placed while racing four-wide, caught SWIFT N TRAFFIC to gain the lead nearing the eighth pole and then proved best under strong handling. SWIFT N TRAFFIC vied for the early lead with GYPSY'S SOULMATE then responded when headed by WIDE VERDICT nearing the eighth pole and held on gamely during the drive. CITY PARK was reserved off the early pace, came three-wide into the stretch and rallied late. GALLANT STAR settled in the middle of the field early, came four-wide into the stretch and went evenly. HOOSIER was allowed to settle, came five-wide into the stretch but lacked a rally. GYPSY'S SOULMATE vied with SWIFT N TRAFFIC for the early lead and weakened. INFINITESIMAL was prominently placed early while racing three-wide and tired. MUFFIN NUTS stumbled at the start then was unhurried, rallied five-wide into the stretch but was unable to seriously threaten. ZION saved ground chasing the early pace and gave way. WISE GUY dropped back early and failed to menace.
