BREAKING STONES Away on top, in hand six wide early, four wide into the lane, responded and rallied for the win. FORTY TWO ACE Contested the lead five wide, three across at the top of the lane, drifted out leaving the furlong marker under left handed pressure making it tight on NO CONFESSION and then outran that one for the place. NO CONFESSION Unhurried along the three path, two path midway around, angled out some, appeared in tight when FORTY TWO ACE drifted out leaving the furlong marker, checked, altered out nearing the sixteenths pole and finished well. DISCO DEANO Vied for the lead along the two path, drifted out at the top of the lane bumping with WARRIORS REVENGE, took charge a furlong out and then faltered in the late stages. OLD MAN WINTER In hand along the two path early, saved ground on the turn and weakened inside. WARRIORS REVENGE Vied for the lead form between, was bumped by DISCO DEANO at the top of the lane and then could not keep up. Claims of foul lodged by the rider of NO CONFESSION against the winner and FORTY TWO ACE for interference around the furlong marker, was not allowed. Also a Stewards inquiry posted concerning the stretch run.
