TORTUGA ISLAND was wellback in the six path early, improved up the backstretch, bid in the four path passing the quarter, dueled with a stubborn inner foe to the wire, and inched ahead in the final strides. CODE OF CONDUCT stalked in the three path, took the lead passing the half, received a right handed cue midway around the far turn, dug in gamely while dueling with an outer foe into the final furlong, but was edged out in the closing stages. MISS TENA MARIE trailed in the five path up the backstretch but improved in the final furlong to get up for show. TWO HEARTED raced off the pace in the five path, flattened from the six path in the final furlong, pulled up after the finish and was precautionarily transported off the track in an equine ambulance. HOT DAME laid up close in the three path, floated out to the six path at the top of the lane, and weakened. WICKED SKY chased in the four path but faded in the six path down the stretch. BEAUTIFUL SUMMER set the pace in the two path, lost the lead passing the half, and yielded in the stretch. VISIONISTA rated in the two path but made no closing bid.
