AWESOME DREW chased out in the six path early, was coaxed along in the five path around the turn, ranged up to bid passing the quarter, swept to the lead while angling inwards at the top of the lane, and kicked away from the two path in the final furlong. FIVEO'CLOCKCHARLIE prompted the pace in the four path, bid between foes in the three path around the turn, led passing the quarter, but got overtaken by the winner while along the rail at the top of the stretch, then finished evenly. STANCE raced off the pace inside, was coaxed along in the three path around the turn, fanned out to the seven path at the top of the lane, and kept on for show. ADIOS KID raced off the pace in the three path but made no closing bid from the five path down the stretch. CENZONTLE stalked in the five path, bid in the four path around the turn, but faded down the lane. R U JOKING bumped with an outer foe at the start, pressed in the two path but gave way in the stretch. VOLODYMYR Z bumped with an inner foe at the start, set the pace in the four path, was cued between foes in the two path passing the quarter, but gave way. NO CHANGES WERE MADE AFTER THE RIDER OF VOLODYMYR Z OBJECTED AGAINST THE RIDER OF FIVEO'CLOCKCHARLIE FOR INTERFERENCE AT THE TOP OF THE STRETCH.
