## Footnotes | View Glossary Of Terms

W W GRAND FINALE stalked in the four path, ranged up to bid in the three path passing the quarter, floated out to the five path on her left lead in upper stretch, took the lead passing the eighth pole, and edged clear. BIKINI MARTINI bumped with an outer foe at the start, trailed in the six path, was ridden in the four path around the turn, fanned out to the seven path at the top of the lane, and ran on while on the left lead to get up for place. MAMA'S MEMORIES bumped with an inner foe at the start, set the pace in the two path, was cued passing the quarter, swung from the three path into the lane, but flattened in the final furlong. LYLAH RENEE rated, was coaxed along the inside around the turn, but weakened in the final furlong. FAITH HOPE N LOVE pressed in the three path but gave way in the stretch.
