MILAALAH stalked in the five path, was coaxed in the four path passing the quarter, and chased home the winner to be second best. CLASSY EMILY raced off the pace inside and finished evenly to get up for show. MIDNIGHT DATE had a slow start, trailed in the four path and was one paced down the lane. SASSY JULIA tracked in the four path, was driven in the two path around the turn, but faded down the lane. MAYA'S WARRIOR chased in the six path but weakened.
