HIGH STRIKE led the way on the inside up the backstretch, continued around the turn in the two path and drew off in the stretch. IMPROPTUDE stalked the leader on the outside early, navigated the turn from the three path and chased on to the wire. SIXTEEN CIGARETTES raced off the pace up the backstretch, saved ground around the bend and improved position while drifting some in the lane. TAPIT'S DIRECTION raced at the back of the pack on the inside through the opening stages, came around the turn in the four path and gained ground mildly in the stretch. DAVID'S SONGS raced in the middle of the pack up the backstretch, continued around the bend in the four path and was outkicked in the lane. GOLDEN SOMBRERO raced at the back of the pack on the outside through the opening quarter, swung out to the five path coming around the turn and made no bid. AUSTONIAN pressed the pace between horses up the backstretch, navigated the turn from the two path and faded in the stretch. JIGSAW bobbed slightly leaving the gate, recovered to chase the leader between horses up the backstretch, raced in the three path around the turn and tired in the lane.

MAJESTIC DRIVE prompted the pace in the three path, took over in upper stretch and drew off under left-handed urging. GULFSTREAM MARY D set the pace in the two path, could not resist the winner in upper stretch but dug in to hold the place. D'ARGENTO BOLT bumped with C C GIRL at the start and again soon after, raced off the pace three wide, advanced four wide around the far turn but was one-paced through the lane. AWESOME CAMPAIGN was bumped after the start, raced off the pace three and four wide and lacked the needed rally. HIT SONG failed to menace while racing two wide. C C GIRL bumped repeatedly early, raced four and five wide and never threatened. PRETTY THING (IRE) chased the pace inside and came up empty in the lane. MISS PAOLA raced in range four wide and had no response.

RIVER OF TIME bumped lightly with GEMSTONE WARRIOR while racing in the two path around the first turn, stalked the leader on the outside up the backstretch, continued around the far turn in the two and three path, began a bid passing the quarter pole and kicked clear in the lane. SWINGING SOLO brushed with the horse to his inside leaving the gate, recovered to lead the way on the inside around the first turn and up the backstretch, continued to save ground around the far bend and was caught in late stretch. LEGAL MANEUVER saved ground early, raced off the pace up the backstretch, swung out to the four path coming around the far bend, began a bid entering the stretch and improved position from there. BANDOOLA raced in the four path around the first bend, settled in the middle of the pack on the outside for the run up the backstretch, came around the far turn in the three path and finished evenly. PREMIADO raced in the three path around the first turn, pressed the pace on the outside up the backstretch, navigated the second turn from the two path and weakened in the lane. GEMSTONE WARRIOR bumped mildly with RIVER OF TIME while racing in the three path around the first turn, settled in the middle of the pack on the inside for the run up the backstretch, continued around the far turn in the two path and made no bid. BEAN MACHINE saved ground early, chased the leader on the inside up the backstretch, continued to save ground around the far bend and tired in the stretch. ROMERO brushed with the horse to his outside at the start, raced in the three path around the first turn, trailed the field up the backstretch, saved ground around the second turn and was never a factor.
