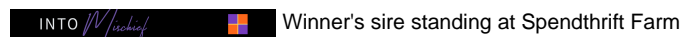

TRUST ACCOUNT pressed the pace three wide around the first turn and two wide around the far turn, took over turning for home and edged clear under a drive. RULES AND REGS stalked the pace from the rail, tipped three wide in upper stretch, bid outside of the winner in midstretch but was turned back. CALL ON ME saved ground off the pace, swung four wide nearing the eighth pole and rallied through the final furlong. HOW ABOUT NOW broke a step slowly, raced off the pace three wide, swung out in upper stretch and rallied belatedly. FLETCH'S ROCKETTE set the pace along the rail and weakened through the stretch. MISTBORN trailed inside, swung six wide near the quarter pole and never threatened. DANCE CLASS chased the pace two and three wide and faded through the stretch. TIZ PRACTICAL was outrun while racing three and four wide.

MAGIC RED showed the way while clear and racing off the rail, drew out on the far turn while in the three to four path, came five wide off the turn and was given a couple right handed reminders with the crop and then shown the crop to the wire to maintain a safe margin to prove best. JIMBO BAILEY tracked the early pace three wide on the first turn, moved in nearing the half mile marker and raced two wide to the inside on the far turn and ran on willingly to the wire but had to settle for being clearly second best. DOMINICAN PIRATE was allowed to settle two wide and remained in the two path while racing evenly to best the rest. UFO (PER) was bumped between rivals at the break, reserved on the inside and lacked a rally. REPROCHE tracked the pace along the rail on the first turn, stayed on the rail to the five sixteenths and moved out to come five wide off the turn but tired. OLD MARSH was reserved two to three wide on the first turn, three to four wide on the far turn but never threatened. VAN CLEEF was bumped at the break, settled back three wide on the first turn, moved in and saved ground on the far turn and never factored. R MARKOVICH bumped with a rival at the start, outrun early and was three wide by the quarter pole but had no response.

CONCORD GREEN was well rated off the inside two to three wide watching the front three pacesetters through the first seven furlongs, made a three to four wide run on the far turn and came five wide off the turn and hit the front nearing the furlong marker, idled once in front and had a long drive but held off OPERATION OVERLORD coming back on his inside to prevail. OPERATION OVERLORD stalked the early pace three to two wide and then took over entering the far to and moved to the inside , then was headed and passed by the furlong marker but dug in and fought back gamely but missed. HALL MONITOR was three wide on the first turn and settled on the outside, then still three wide on the far turn moved in to be two wide by the quarter pole, split rivals by the three sixteenths and angled out by the furlong marker and was gaining late. OFFLEE NAUGHTY checked shortly after the start on the inside, continued to saved ground for about seven furlongs and moved out down the backside and made a three to four wide run on the far turn and came five wide into the lane and then was bumped by the furlong marker and then rallied mildly late. PIERRE was allowed to settle along the inside, continued to save ground and was boxed and waited for room by the quarter pole, blocked leaving the turn and then when asked inside the furlong grounds had no punch. JUST FOR LUCK was reserved early, made way to the inside and saved ground on the far turn and angled out leaving the three sixteenths and then was bumped and steadied by the furlong marker and then ran on late. VINTAGE VINO was reserved early, three wide into the lane but had no rally. PROFOUND was reserved along the inside and then two wide on the far turn but failed to menace. SPY NOVEL was close up early on the inside, then rated back and moved out to be three wide down the backside, made a three wide bid on the far turn and was in between rivals nearing the furlong marker, angled out leaving the eighth pole and bumped a rivals and then weakened. DONTSPASHTHEPOT set the pace for a mile and then gave way entering the far turn and then was eased and pulled up before the wire, was vetted and treated on the turf course and loaded on to the equine ambulance for further evaluation.
