GULFSTREAM MARY D showed good early speed and assumed command away from the start, made her own pace through the backstretch, well handled to the quarter marker, kept to task through the stretch and held sway late. THUNDER PRINCESS tracked the pacesetter three to four wide, needed more late but rallied for second. BEENTEE allowed to settle while saving ground, got caught in traffic into the far turn, angled five to six wide into the lane, closed well late and just missed for second, while getting up in time for third. POCKET PAIR settled between foes and two wide, gained ground to upper stretch, could not sustain that run late and finished evenly. ATTENDING tracked inside, tipped two wide at the quarter pole, outkicked stretch. SAINTE CHAPELLE tracked between two to three wide, no late kick. PHARAOH'S FAVORITE settled inside, bid to upper stretch, got put in tight late and flattened. SMART STYLE unhurried, raced widest to the half marker marker, chased five wide upper stretch, went evenly through the drive.

TIMBER settled outside of rivals early on, raced widest to the half-mile marker, roused four wide into the far turn, battled CASH DUE to mid-stretch, repelled that foe into the final sixteenth and drew clear late. CASH DUE contested the early pace, took back into the far turn then re-bid three wide to upper stretch, battled to the furlong grounds, yielded late and was second best. LA CYBER settled mid-pack, chased three wide to upper stretch, needed more late but stayed on and gained third. BASILICA LIGHT stalked the pace three wide, vied for the lead at the quarter marker, could not keep pace into the lane and weakened in the final furlong. LOYALIST settled inside, passed tiring rivals stretch. NOT ONE LESS took up start, lagged early, swung six wide upper, no threat late. WORTH CONSIDERING contested pace to quarter marker, gave way stretch. ONEMORSILVERDOLLAR well placed inside, faded past half-mile. PARTY QUEEN settled inside, saved ground to stretch, no factor. A FANCY SOLUTION settled second flight, two to three wide to far turn, tired.

MIGUEL'S BELLE broke alertly, contested the pace three wide to the turn, took command nearing the top of the stretch then drew off in the final furlong and was ridden out to win as much the best. CAJUN ANTHEM pressed from the inside, angled out upper stretch, was no match for the winner and was second best. IT'S ONLY WORDS broke in air and spotted the field to begin, saved ground to stretch, could not impact the top pair late and ran on for third. AMY THE BUTCHER off slow to begin, rushed inside then was caught in tight into the turn, angled six wide to upper stretch then was outkicked. PATTY'S HAVING FUN tracked three to four wide to stretch and weakened in the drive. FOXY LADY chased between foes and two wide to the quarter marker, tired stretch. MINXY hustled away from the start, contested pace two wide to turn, gave way nearing the quarter marker. THE STEWARDS CONDUCTED AN INQUIRY INTO THE START INVOLVING IT'S ONLY WORDS AND DETERMINED THAT RUNNER CAUSED HIS OWN ISSUES AND TOOK NO ACTION. IN ADDITION, THE JOCKEY OF CAJUN ANTHEM LODGED AN OBJECTION AGAINST THE JOCKEY OF MIGUEL'S BELLE, CLAIMING INTERFERENCE. THE STEWARDS DISALLOWED THAT OBJECTION AND RULED THERE WOULD BE NO CHANGE.
