NO MO COOKIES broke alertly, set the pace while well handled to the far turn, drew clear to upper stretch, held sway through the lane. LISCA BIANCA well

placed inside, angled three wide far turn, could not impact the winner late and closed for second. MARABINA tracked three wide to backstretch, chased winner along the second turn, lacked a final response in the drive and lost second. BLUSHING TIGER settled, gain three wide quarter marker, chased to mid-stretch, outkicked late. LILYS BACK settled inside, got caught in traffic far turn, chased three wide to upper stretch, not enough late. STARLIGHT LUNA lacked early speed, advanced five wide far turn, finished evenly. SHINES MADELIN settled mid-pack, chased four wide to quarter marker, no late response. CHICA CATHOLIC broke out and was away slowly, unhurried to the backstretch, swung six wide to upper stretch, no factor. FREE CHARGING tracked three wide to backstretch, shifted in and chased from the rail to the quarter marker, could not keep pace into the lane and tired. SPUN TO PURFECTION stalked inside to second turn, gave way nearing the quarter pole, eased stretch, walked off.
