NEOPHYTÉ vied for the early lead from outside, took command heading to the turn then kicked clear nearing the quarter marker, kept to task through the lane and drew away late. MISTER ICEMAN rated off early pace, angled four wide into the turn, could not impact the winner late but rallied to be a clear second. TAP GOLD pressed early pace three wide, chased the pacesetter two wide nearing the quarter marker, outkicked in the stretch and just held third. REVEREND MOON rated off the early pace, angled three wide turn, steady gain to mid-stretch, flattened out late. SOUPER WATSON shuffled early, chased outside, coaxed three wide to upper stretch, no late bid. FROSTY SHOP pressed early pace inside, put in tight and checked hard three-eighths, stayed on to upper stretch and weakened. BREEZER disputed early pace between foes, shifted in approaching the turn and bothered FROSTY SHOP, chased to upper stretch, gave way. FAIRWAY TO HEAVEN settled early, got caught in tight between foes and took up at the three-eighths, coaxed four wide to upper stretch, no rally. THE STEWARDS CONDUCTED AN INQUIRY INTO THE INCIDENT INVOLVING FROSTY SHOP TAKING UP ENTERING THE TURN. THE STEWARDS DETERMINED BREEZER INTERFERED WITH FROSTY SHOP ON THE RUN TO THE FAR TURN. HOWEVER, AS FROSTY SHOP FINISHED AHEAD OF BREEZER, NO ACTION WAS TAKEN.
