I'M SAM allowed to settle early, loomed four then five wide at the quarter marker, rallied to contention at mid-stretch, closed determinedly into the final sixteenth then surged in the final strides to prevail. CANDY ROAD vied for the early lead then rated off of the pace, was well placed to the turn, got caught in traffic nearing the quarter marker, found room into upper stretch then took command at the furlong grounds, dug in when challenged approaching the final sixteenth, was bested for the win in the final strides and was well clear for second. DON'T GO ASTRAY sent for the early lead, assumed command and set a decent pace to the quarter pole, led to upper stretch then was overtaken nearing the furlong marker, yielded to the top pair nearing the final sixteenth and just held for third at the wire. LOVETHISBIZZ lunged at the start and was off slowly, advanced outside of rivals along the turn, swung five to six wide for the stretch drive, was outkicked into the final furlong and just missed for third. FIFTEEN HUNDRED R settled while saving ground early on, angled four then five wide for the stretch drive, advanced at the furlong marker then flattened out late. RISTRE tracked the pace three wide to the quarter marker, chased four wide into the stretch then weakened. GOLDEN AMBITION raced close up in the early stages, stalked the pace to the quarter pole, ran in pursuit to mid-stretch then came up empty late. AWEGOD tracked the early pace two wide and from between runners, could not keep pace to upper stretch then tired in the drive. ILLUSTRATION lacked early speed, trailed to the quarter marker and did not factor in the stretch.

ZO ZUCCHERA unhurried in the early going, worked to the outside of rivals along the backstretch, asked for run three wide nearing the quarter pole, vied for the lead into upper stretch, took command at the furlong grounds then kicked clear in the final sixteenth. SEEKING A PRAYER rated off of the early pace, saved ground to the backstretch, lost position nearing the quarter marker, angled out and re-rallied nearing the furlong grounds, could not impact the winner late and closed for a share of the place honors. LATTE LIZZIE forwardly placed early on, stalked the moderate pace to the second turn, chased from the inside into upper stretch, was outkicked in the final furlong and just held for a share of second. GULFSTREAM MARY D sent for the early lead, set a moderate pace to the far turn, met oncoming bids into upper stretch, could not keep pace into the final sixteenth and faded late. VINO LIMONE allowed to settle while never far back, trailed into the second turn, swung widest for the stretch drive then could not find the needed late response. SMOOTH CLARET tracked the early pace from outside of rivals, gained ground three then two wide into the far turn, was outkicked to mid-stretch then gave way in the late stages.

GIRL IN BLUE showed good speed away from the start, assumed early command and set a decent pace to the quarter marker, held sway to mid-stretch then pulled away late under steady urging. TOP POCKET PICK tracked the early pace, chased two wide and between runners nearing the quarter pole, ran in pursuit of GIRL IN BLUE to mid-stretch, could not match strides with the winner into the final sixteenth and was second best. DERBY HANGOVER settled off of the early pace, chased from the two path into upper stretch, could not impact the top pair late and ran on to earn the show honors. MARANTA settled off of the early pace, asked for run four wide nearing the quarter marker, spun five wide for the stretch drive, could not sustain his run to the final sixteenth and flattened out late. MONEY BATTLE rated off of the early pace, got to the rail and tracked the pace into the turn, was well placed to the quarter marker, ran in pursuit to mid-stretch, could not find a late response and weakened in the final sixteenth. STARSHIP MAXIMUS hustled to be forwardly placed early on, chased the pace two then three wide nearing the quarter marker, was outkicked to mid-stretch then tired in the late stages. TIZ FOR MATT lacked early speed, trailed into the turn and did not mount a late rally.

NESHUME rated off of the early pace while never far back, mounted a four wide bid at the quarter marker, was gaining into the final furlong, could not reel in the winner late and held for second. BLAST RADIUS tracked the early pace from the inside, was caught in traffic nearing the quarter marker and angled five to six wide for the stretch drive, finished well in the late stages and was clear in the end for third. MR. PEEKS contested the pace two wide and between runners, was outkicked to mid-stretch then faded in the final sixteenth. EL GUTY disputed the pace three wide and between rivals into the turn, lost position to upper stretch and weakened in the drive. SPEED CONTROL unhurried in the early going, trailed to the quarter marker and did not factor in the stretch. LE AMAZONIA rated nicely off of the early pace, loomed three wide nearing the quarter marker, took command to upper stretch, drew away through the lane and was kept to task in the final sixteenth. ROYALLY BLUE squeezed at the start and off a bit slowly, advanced two then three wide and between rivals nearing the quarter pole, angled five wide for the stretch drive, could not make headway on the winner into the final furlong and held safely at the finish for second. GRANKA settled in the early stages, advanced three then four wide leaving the quarter marker, split rivals into the final furlong, was outkicked in the final sixteenth and held for third. THE DOVE RULES a step slow leaving the start, lacked early speed and trailed into the turn, swung six to seven wide for the stretch drive, could not find the needed late response and passed tiring rivals. LOVE ACTUALLY close up in the early going, checked when put in tight approaching the turn, stalked from the inside nearing the quarter marker, got caught a bit in tight into upper stretch then gave way in the drive. BREEZEY Z vied for the early lead from between runners, stalked the pace two wide to the quarter marker, chased three wide into the stretch and tired in the late stages. CHECK THE GRADE broke alertly, showed good early speed and set the pace up the backstretch, drifted over a path approaching the turn then dictated terms heading to the quarter marker, was overtaken to upper stretch and came up empty in the final furlong.
